INTRODUCTION

DATA

What we gather

We may collect the following information:

- Name and Job Title
- Contact Information including email address and phone number
- Website usage data

How we use this data

By collecting data it helps us understand what you are looking from the company, enabling us to deliver relevant product and services.

Specifically, we may use data:

- For our own records
- To improve the services we provide
- To contact you in response to a specific enquiry
- To personalise and improve your interaction with the website
- To send you promotional emails about products, services, offers, events and other things we may think are relevant to you
- To send you promotional mailings or to call you about products, services, offers, events and other things we think might be relevant to you
- To contact you via email, telephone or mail for market research purposes

COOKIES & HOW WE USE THEM

What is a cookie?

A cookie is a small file placed on your computer's hard drive. It enables our website to identify your computer as you view different pages on our website.

Cookies allow websites and applications to store your preferences in order to present content, options or functions that are specific to you. They also enable us to see information like how many people use the website and what pages they tend to visit.

How we use cookies?

We may use cookies to:

- **Analyse our web traffic using an analytics package.** Aggregated usage data helps us improve the website structure, design, content and functions.
- **Identify whether you are signed in to our website.** A cookie allows us to check whether you are signed in to the site.
- **Test content on our website.** For example, 50% of our users might see one piece of content, the other 50% a different piece of content.
- **Store information about your preferences.** The website can then present you with information you will find more relevant and interesting.
- **To recognise when you return to our website.** We may show your relevant content, or provide functionality you used previously.

Cookies do not provide us with access to your computer or any information about you, other than that which you choose to share with us.

Controlling cookies

You can use your web browser's cookie settings to determine how our website uses cookies. If you do not want our website to store cookies on your computer or device, you should set your web browser to refuse cookies.

However, please note that doing this may affect how our website functions. Some pages and services may become unavailable to you.
